1. SWEEPSTAKES PERIOD.

The EVO Ticket Giveaway begins at 12:00:00 a.m. Central Time (“CT”) on Jan. 22, 2024, and ends at 11:59:59 p.m. CT on Jan. 25, 2024 (“Sweepstakes Period”). Sponsor’s or its designee’s computer is the official timekeeping device for the Sweepstakes.

Participation in the Sweepstakes does not constitute participation in any other promotion, contest, or sweepstakes.

2. ELIGIBILITY.

To enter the Sweepstakes, entrants must (a) be legal residents of Texas with a primary residence address within Dallas, Texas excluding residents within seventy-five (75) miles from either the Chesapeake Energy Arena in Oklahoma City, OK, the AT&T Center in San Antonio, TX or the Toyota Center in Houston, TX; (b) Eighteen (18) years of age or older at the time of entry; (c) have a valid email address; and agree and adhere to these Official Rules. This Sweepstakes is void outside the State of Texas and where prohibited by law. This Sweepstakes and any website pages and advertisements relating thereto are intended for viewing only within the State of Texas. Employees, officers, directors, and agents of EVO ENTERTAINMENT GROUP (“Sponsor”) and its parents, subsidiaries, affiliates, retailers, and advertising or promotion agencies and vendors involved in this Sweepstakes (collectively, “Sweepstakes Entities”), and their immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and household members of all such persons, whether or not related, are not eligible to participate in this Sweepstakes. NBA Media Ventures, LLC, the National Basketball Association and its Member Teams, and each of their respective parent, subsidiary, and related companies and divisions are not eligible to participate in the Sweepstakes.

3. HOW TO ENTER.

To enter, entrants must visit www.evo-cinemas.com/mavsbdays and enter their name, valid email address, zip code, and phone number, and may consent to receive advertising e-mail messages from Sponsor (optional) (each an “Entry”; collectively,

“Entries”). All entries must be received by January 25, 2024, at 11:59:59 p.m. CT. Limit one (1) Sweepstakes Entry per person. Proof of entry submission is not proof of receipt. Standard internet access fees apply.

4. LIMIT.

Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) Entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's Entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

5. WINNER SELECTION/ODDS.

Potential prize winners will be selected by a random drawing from among all eligible Entries. The drawing will be conducted on or about January 26, 2024, in Austin, Texas by Sponsor or its designee, whose decisions will be final and binding in all matters relating to this Sweepstakes. Odds of winning a prize depend on the number of eligible Entries received. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner of the Entry Period will be declared an official winner of the Sweepstakes.

6. PRIZES.

Approximate Retail Value (“ARV”) of all prizes: Three hundred and twenty-nine dollars and eighty cents (\$329.80) total.

- (a) Grand Prize (One (1) available): One Winner will receive an EEG Lime party package with a Dallas Mavericks party add-on for up to ten (10) guests, based on availability of room. The prize package includes two (2) pizzas, unlimited soft drinks for the duration of the one-hour event, one (1) hour of arcade game play, one (1) hour of exclusive use of an EEG private party room, and one (1) dedicated party host for the duration of the event.

Sponsor is not responsible for inability of winner to accept or use prize and prize may be forfeited if winner cannot accept or use prize. 8. WINNER NOTIFICATION.

A potential winner ("Selectee") will be notified by email to the address provided in the Entry and asked to respond as directed within six (6) hours to Sponsor with his/her name, address, telephone number, and date of birth. If a Selectee does not respond within six (6) hours or does not timely comply with any subsequently provided prize redemption instructions, that Selectee will be disqualified, and an alternate Selectee may be chosen at random from among all eligible entrants. Selectee may be required to sign, notarize, and return an affidavit of eligibility, a liability release, and publicity release within seven (7) days of prize notification or the prize may be forfeited in its entirety, and an alternate Selectee will be chosen. Any unclaimed prize will be forfeited.
